


## Social Media

### intended use v. actual us



Technology to facilitate the sharing of idea, thoughts, and information through virtual networks

Instead, it has become a platform for negative peer exploitation



### Social Media and Your Mental Health



#### Alters one's mood

Sets unrealistic expectations

Opens them up to online bullying

Equally can be positive and negative

## Cyberbullying

Bullying taking place over digital devices

Cell phones, computers, and tablets

Sharing personal information to cause embarrassment

Potential to cross into criminal behavior

Face the potential consequence in removing you from your home



# **Consequences for Cyberbullying**



Bullying on public platforms

The punishment increases based on severity and quantity

1<sup>st</sup> offense – 93 day misdemeanor

2<sup>nd</sup> offense – 1 year misdemeanor

Continued pattern – 5 year felony

Causing death – 10 year felony


## Bullying by Texting and Calling

Malicious use of telecommunication service provider

Threatening via text messages

Using vulgar or offensive language

Repeatedly calling and hanging up



## **Social Media Statistics**

Access to a smartphone

Nearly half are online constantly

Increase since the pandemic

Impact on boys is at an older age than girls



Boys and girls both correlate their social media with life satisfaction



## Child Sexually Abusive Material

Nude photographs or videos of children


Anyone under 18 is considered a child

Sending and receiving this material has criminal consequences

Dating or not, it still has consequences

Remember, nothing is ever deleted





Possession of CSAM – Four year felony

Distribution of CSAM – seven year felony

Sex Offender Registration

Potential to have other charges attached

Protect your mental health

## School Shootings Statistics

### 1,924 school shootings since 1970

2021 had the greatest number of incidents

637 people have died in school shootings since1970



## School Threats and the Consequences

If you want to live tomorrow I recommend not coming to school we tired of being bullied and bothered for no reason



Threatening to commit violence against students or employees on school property

Threats can be verbal or in writing

Threat – one year misdemeanor Threat and taking steps to completion – ten year felony

Both can result in removal from your home
